Page 2, LIQUIDATED DAMAGES

DELETE:

If said work is not Substantially Complete within 330 calendar days as stated in the Notice to Proceed, the Contractor shall be liable and hereby agrees to pay to the Owner as liquidated damages, and not as a penalty, the amount of **one thousand five hundred dollars (\$1,500.00)** per calendar day for each and every part of a day thereafter that said work is not Substantially Complete. If said work is not fully completed within 30 calendar days after the date of Substantial Completion as stated in the Notice to Proceed, the Contractor shall be liable and hereby agrees to pay to the Owner as liquidated damages, and not as a penalty, the amount of **seven hundred fifty dollars (\$750.00)** per calendar day for each and every part of a day thereafter that said work remains incomplete.

REPLACE WITH:

If said work is not Substantially Complete within 390 calendar days as stated in the Notice to Proceed, the Contractor shall be liable and hereby agrees to pay to the Owner as liquidated damages, and not as a penalty, the amount of **one thousand five hundred dollars (\$1,500.00)** per calendar day for each and every part of a day thereafter that said work is not Substantially Complete. If said work is not fully completed within 60 calendar days after the date of

Substantial Completion as stated in the Notice to Proceed, the Contractor shall be liable and hereby agrees to pay to the Owner as liquidated damages, and not as a penalty, the amount of **seven hundred fifty dollars (\$750.00)** per calendar day for each and every part of a day thereafter that said work remains incomplete.
