The Invitation for Bid (IFB) for IFB 21037-JS for the Lake Cohoon Bridge Rehabilitation for the Department of Public Works has been amended. The following information is hereby made a part of the Contract Documents for IFB 21037-JS as fully and completely as if the same were fully set forth therein:

REVISION

Page 7 – Liquidated Damages

DELETE the following paragraph:

If said work is not substantially complete within **180** calendar days as stated in the Notice to Proceed, the Contractor shall be liable and hereby agrees to pay to the Owner as liquidated damages, and not as a penalty, the amount in accordance with VDOT Road and Bridge Specifications Table I-1, Section 108.06(b) per calendar day for each and every part of a day thereafter that said work remains substantially incomplete.

INSERT the following paragraph:

If said work is not substantially complete within **330** calendar days as stated in the Notice to Proceed, the Contractor shall be liable and hereby agrees to pay to the Owner as liquidated damages, and not as a penalty, the amount in accordance with VDOT Road and Bridge Specifications Table I-1, Section 108.06(b) per calendar day for each and every part of a day thereafter that said work remains substantially incomplete.

Page 41 - last sentence

DELETE the following sentence:

Bidder agrees to begin the Work within ten (10) days of Notice to Proceed, and that Final Completion shall be on or before two hundred and ten (210) consecutive calendar days after the Notice to Proceed date.

INSERT:

Bidder agrees to begin the Work within ten (10) days of Notice to Proceed, and that Final Completion shall be on or before three hundred and sixty (360) consecutive calendar days after the Notice to Proceed date.
